**NOTICE TO CANE PLANTERS
FINAL ROAD RATE – CROP 2020**

The Control and Arbitration Committee, in accordance with Section 40(2)(b) of the Mauritius Cane Industry Authority Act 2011, has on 09 February 2021 determined the Final Road Rate for Crop 2020.

The variable Rate where the transport is undertaken by the planter and the distance over which a planter's canes are transported to a factory or Cane Transit Site is greater than 6.4 kilometres is as follows:

- (a) For planters supplying up to 100 tonnes of canes: Rs 8.04 per tonne per km
- (b) For planters supplying above 100 tonnes of canes: Rs 7.31 per tonne per km

Where the transport is undertaken by the miller, the variable and the fixed rates for the first 6.4 kilometres are as follows:

- (a) Variable Rate: Rs 7.31 per tonne per km
- (b) Fixed Rate: Rs 26.20 per tonne

Any party who is not satisfied with the determination may appeal against it by forwarding to the Committee a letter stating the grounds of the appeal so as to reach the Committee not later

than twenty-one (21) days from the date of the last publication of this Notice.


