General Notice No. 529 of 2021

THE QUARANTINE ACT 2020

Order made by the Prime Minister under section 3 of the Quarantine Act 2020

1. WHEREAS by virtue of General Notice No. 512 of 2021, I ordered, pursuant to paragraph 4(2) of the said Order, that persons resident in an area listed in the Appendix to the said Order shall, at no time, travel outside that area and, persons not resident in an area listed in the Appendix to the said Order shall, at no time, enter that area.
2. NOW, I order that persons resident in an area as described in the Appendix to this Order shall, at no time, travel outside that area and, persons not resident in an area as described in the Appendix to this Order shall, at no time, enter that area.
3. This Order shall be in addition to, and not in derogation from, the Order made by virtue of General Notice No. 512 of 2021.
4. The Appendix to General Notice No. 512 of 2021 is revoked.
5. General Notice No. 516 of 2021 is revoked.

PART I

Along A10 Forest Side Road from its junction with Bonnefin Street to its junction with Access Road leading to Ferney Spinning Mills

(d) Western Side

By natural features: Trois Mamelles, Sept Cascades, Tamarind Falls Reservoir and Mare aux Vacoas
