The summary financial statements, which comprise the summary statement of financial position as at 31 December 2019, the summary statements of profit or loss and other comprehensive income, changes in equity and cash flows for the year then ended are derived from the audited financial statements of HABIB BANK LIMITED (MAURITIUS BRANCH) (the "Bank") for the year ended 31 December 2019.

We draw attention to Note 2(a) of the audited financial statements, which indicates that the Bank incurred a net loss of MUR 17,202,000 during the year ended 31 December 2019 and, as of that date, the Bank's total assets exceeded its total liabilities by MUR 465,863,000. As stated in Note 2(a), these events or conditions, along with other matters as set forth in Note 2(a), indicate that a material uncertainty exists that may cast significant doubt on the Bank's ability to continue as a going concern. Our opinion is not modified in respect of this matter.

In our opinion, the accompanying summary financial statements are consistent, in all material respects, with the audited financial statements, on the basis described in Note 1.

Summary Financial Statements

The summary financial statements do not contain all the disclosures required by International Financial Reporting Standards and in compliance with the Mauritius Companies Act, Banking Act and Financial Reporting Act. Reading the summary financial statements and our report thereon, therefore, is not a substitute for reading the audited financial statements and our report thereon. The summary financial statements and the audited financial statements do not reflect the effects of events that occurred subsequent to the date of our report on the audited financial statements.
