- 1. Notice is hereby given that
  - (a) any publication of a notice or an advertisement in the *Gazette* shall be charged, and paid for, at the following rates –

- (vi) balance sheet/tabular forms

- (vii) in case the space occupied by a notice falls between any of the sizes specified under subparagraph (vi), it shall be charged to the nearest format;
- (b) any notice sent for publication shall be paid for at the rates specified under subparagraph(a) after they have been formatted in column, irrespective of whether they are subsequently cancelled or withdrawn by the sender before publication;

- (c) every application for publication in the *Gazette* shall be paid in full at the time of application;
- (d) the rates specified under subparagraph(a) shall be inclusive of one copy of the *Gazette*;
- (e) the rate payable in respect of a yearly subscription to the *Gazette* and Extraordinary *Gazette* shall be 2,500 rupees;
- (f) the rate payable in respect of one copy of the *Gazette* and Extraordinary *Gazette* shall be 25 rupees;
- (g) (i) any notice for publication in any ordinary Saturday issue of the *Gazette* shall, subject to sub subparagraph (ii), reach the Government Printing Office not later than 2.30 p.m. on the Thursday in the week of that issue;
  - (ii) any notice may be received at the Government Printing Office until 11.00 a.m. on the Friday in the week of that issue on payment of a surcharge of 50 per cent of the rates specified in subparagraph (a);
  - (iii) where a Saturday in any week is a public holiday, sub subparagraphs (i) and (ii) shall, for purposes of the publication of notices in the ordinary issue of the *Gazette* for that week, be read as if the words "Thursday" and "Friday", were substituted by the words "Wednesday" and "Thursday", respectively.
- **2.** Government Notice No. 136 of 1981 and Government Notice No. 1 of 1984 shall have no effect.
- **3.** These directions shall take effect on 1 November 2015.
